**MMRPC Assists Communities with  
Comprehensive Planning Efforts**

Staff members of the Mid-Missouri Regional Planning Commission are in the beginning stages of assisting the communities of Ashland and New Franklin with developing city comprehensive plan. The comprehensive plan is a statement of a community's vision of itself now and a "roadmap" to plan for the future. The plan directs the physical growth, development and redevelopment of the community.

For these communities- it will be the first time in recent years that city leaders will go through the process of combining the many functional parts of the community into a unified document that guides the community to achieve its long-term goals and objectives. Issues that will be addressed include land use, transportation, economic development, housing, parks and recreation, utilities, community design, environmental issues, and historic preservation. The process for creating a city or Comprehensive Plan requires extensive research, analysis and collaboration between these many interests. But most importantly, the Plan must reflect the needs and desires of the community.

The MMRPC is assisting the communities in developing methods to enhance public involvement in the planning process. The citizen's input is critical in helping city leaders and the planning team develop goals and objectives that reflect the community's character and values. The MMRPC is developing a series of various committees and neighborhood meetings, a town hall - community conversation meetings, design charettes, community surveys, public hearings, and other citizen involvement tools in which the community can use in the creation of the Comprehensive Plan.

Both Ashland and New Franklin have recently completed community surveys. At present, the MMRPC is coordinating a series of informational meetings designed to inform citizens of how they can participate in the planning process.

**Missouri's Long-Range Transportation  
Plan Available**

The Missouri Department of Transportation (MoDOT) has completed the *Missouri Advance Planning* or MAP. This document is the long-range transportation planning initiative, which considers a 20-year look into the future. The plan

was presented to the Missouri Highways and Transportation Commission at their April 11, 2007 meeting.

The plan states that Missouri citizens are telling MoDOT the following issues are important to them: First, maintain and improve the transportation system; second stretch tax dollars; and three, secure more funds to help meet their expectations. These opinions and expectations have shifted from prior planning efforts when Missourians identified their highest priority as primarily improving the system's condition. While the condition of Missouri's most traveled highways has greatly improved since that time, Missourians are now mostly expecting improvements in moving people and goods.

An overview of the plan was presented by MoDOT staff to the MMRPC membership at the January 24th commission meeting. During this meeting- discussions included the acknowledgement that current transportation revenues do not buy as much now as they used to buy, that changing traffic patterns which include more truck traffic are leading to busier, more congested highways; and there is a continuing demand for highway and bridge expansion.

**Recreational Trails Grant Program  
Accepting Applications**

The Missouri Department of Natural Resources has begun accepting grant applications from private organizations, and municipal, state and federal agencies for the Fiscal Year 2007 grant round of the federal Recreational Trails Program. The program is funded through the Federal Highway Administration as part of the Safe, Accountable, Flexible, Efficient Transportation Equity Act. A minimum of \$900,000 is expected in this cycle.

Eligible project categories include construction, maintenance, restoration and development of new motorized or non-motorized trails. All grants are awarded on a reimbursement basis; a minimum 20 percent match is required for projects. Applications must be postmarked by July 16, 2007. Grant requests up to \$100,000 are eligible. Eligible applicants include cities and counties, schools, and private, non-profit and for-profit businesses. To assist potential project sponsors with the application process, Department of Natural Resources staff is planning grant application workshops throughout Missouri during the month of May. MoDOT is accepting applications for the Transportation Enhancement Program from local governments to support a variety of "non road improvement" transportation projects. Some eligible activities include sidewalks, acquisition of scenic or historic easements and sites, landscaping and scenic beautification, control and removal outdoor advertising, historic preservation of building and facades in historic districts, restoration and reuse of historic buildings for transportation purposes. **Deadlines are: District 2 (Howard County and communities) May 15, 5 p.m and for District 5 (all other MMRPC counties and communities) May 16, 11 a.m.**

### **Public Safety (CEDAP) Grants.**

The FY07 Commercial Equipment Direct Assistance Program makes available equipment to law enforcement agencies, fire, and other emergency responders who demonstrate the equipment will be used to improve their ability to respond to incidents.
